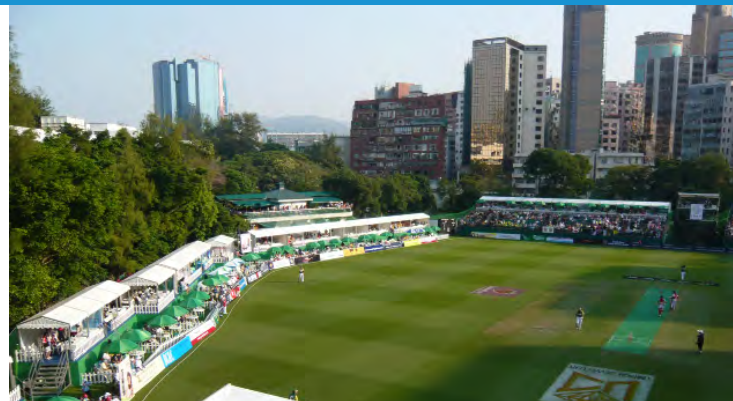

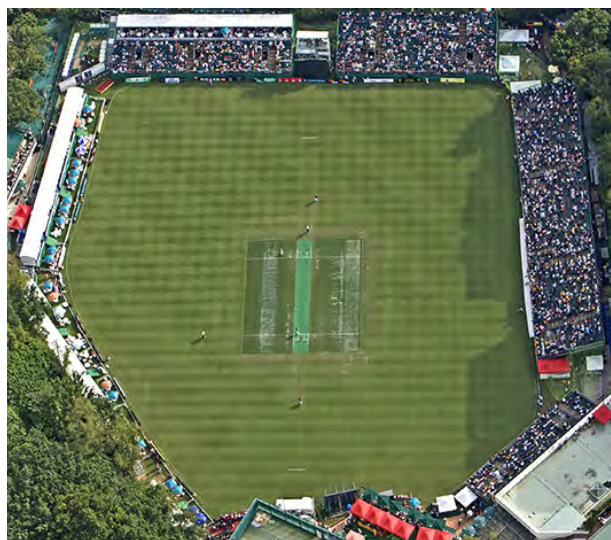
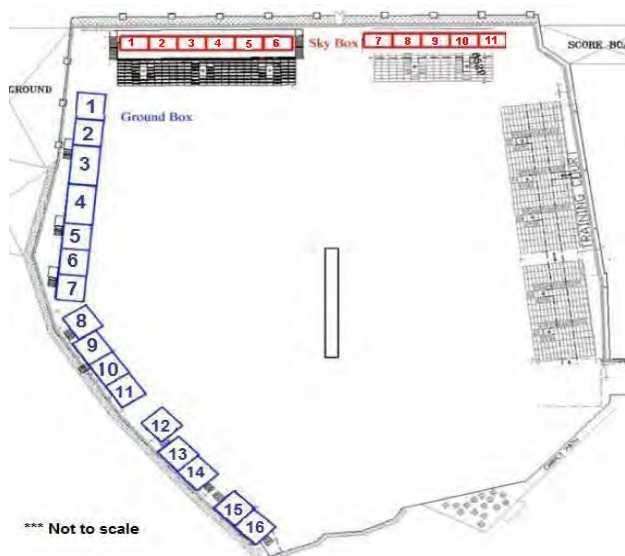

Terms & Conditions

1. The Event. The Hong Kong Cricket Sixes 2010 will be held on 6th November and 7th November 2010 at the Kowloon Cricket Club, Hong Kong SAR.
2. Sponsorship package. The company shall be entitled to the following benefits included in the Corporate Sponsor VIP package:
 - (a) Marquee and garden or terrace (total size approx. 6m x 6m) for 20 guests on each day of the Event
 - (b) total of 40 souvenir programmes;
 - (c) buffet lunch on each day of the Event, continental breakfast on each day of the event (Catering provided by the KCC);
 - (d) full waiter service with complimentary beer and soft drinks on each day of the Event;
 - (e) two (2) PVC wall-panels erected of company's own design, box header; and
 - (f) company logo shall appear in the souvenir programme.
 - (g) Two (2) invitations to the Sixes After Party.
 - (h) Players' Welcome Party. The Company shall receive four (4) invitations to the Players' Welcome Party.
 - (i) One autographed piece of Sixes memorabilia.
 - (j) Half page advertisement space in the Souvenir Programme.
 - (k) Company logo on the sponsorship page of the Sixes website.
3. Beverages. Notwithstanding clause 2 (d) above, the Company shall be responsible for all other alcoholic beverages consumed at the Marquee.
4. Consideration. The Company shall make any and all payments hereunder, to Hong Kong Cricket Association ("HKCA") in full, free from any set-offs, withholdings or deductions of any nature whatsoever.
5. Cancellation/Postponement.
 - (a) If the Event is cancelled or postponed as a consequence of as described in clause 6 below, neither party shall be liable to the other for any loss and /or damage incurred as a result of such cancellation other than as set forth in clause 7 of this agreement.
 - (b) HKCA shall notify the Company promptly in writing of cancellation or substantial reduction in scope of the Event and or any proposed alternative event.
 - (c) If the Event does not take place for any reason excluding an event of Force Majeure referred to in Clause 7, then the Company shall be entitled to a refund of the consideration that they have paid to that date. HKCA will bear no liability for any further loss and/or damage incurred as a result of such cancellation.
6. Force Majeure. HKCA shall be under no liability whatsoever to the Company for any delay in the performance, or non-performance, of its obligations hereunder as a result of circumstances beyond its reasonable control including, without limitation, any delay caused by any act of omission of the Sponsor, Act of God, war, revolution, Government policy, military activities, riot, terrorist act, civil commotion, strike, lock-out, earthquake, flood, fire, health alert, delay in transit, satellite failure, inclement weather (including typhoons), or any failure of any public utility or undertaking.
7. Termination. This Agreement shall commence on the date the application is confirmed and shall expire immediately after completion of the Event.
8. Assignment. The Company shall not assign or purport to assign, sub-contract or otherwise dispose of any of its rights and obligations under this Agreement to any third party without the prior written consent of HKCA (such consents to be given or withheld at the absolute discretion of HKCA).
9. Any notice required to be given hereunder shall be sufficiently given to either party if delivered in person or forwarded by prepaid first class post or via facsimile addressed to the address of the party to be served referred to above or such other address as may from time to time to be agreed in writing between the parties hereto. All notices shall be deemed to have been received when delivered by hand or when dispatched via facsimile (provided that the sender receives an answerback message confirming successful transmission) or three (3) business days after posting or five (5) business days after airmail posting if posted overseas.
10. Law and Jurisdiction. This agreement shall be governed by, and construed in accordance with the laws of Hong Kong SAF and is subject to the exclusive jurisdiction of the Hong Kong courts.
